A. Comments from Broward County Superintendent of Schools - Robert Runcie

Mayor Hunschofsky welcomed Broward County Schools Superintendent Robert Runcie and School Board member Abby Freedman to the meeting.

Runcie recognized the great partnership the School Board and Parkland have had. The partnership has been fruitful in the delivery of classroom additions, and modulars. We work together to meet the needs of the community. The community continues to grow and thrive. One of the attractions are the great schools in Parkland. We will continue to work to make sure we have excellent schools in Parkland. I would also like to be very clear, that Parkland will not be impacted by boundary changes next year. We hope to see you on Monday for a celebration ceremony for the addition at Riverglades.

I would also like to mention, that we believe the quality of education, experience, and resources cannot be matched. Our before care, and after care, programs we have at the schools is more than 860 students who attend here in Parkland. We have many programs throughout the county, and many are here in Parkland. The IB, Cambridge, STEM, computer science, Montessori, performing arts, etc. We have expanded our computer science to more than 50,00 students county-wide. We have delivered more 83,000 computers in Broward County. About 4,000 in Parkland alone. We have invested about \$2.2 million in technology in the past year. Expanded the debate program, which is the largest and strongest in the nation. We even have elementary schools doing debate. We have dual-language programs. We have music. We have delivered more than 33,000 new musical instruments in the past year, and more than 24,000 still to be delivered. Lots of choices and extending learning opportunities here in the county.

I wanted to ensure the City that we can expand capacity if necessary. I think we are in good shape now, and we have additional seats in our schools. We plan for growth here in Parkland in order to accommodate the needs of the community. The partnership with the City has been a model for Broward County. We have other cities coming forward to try and do some of the same things we have accomplished here in Parkland, and I want to thank you for the efforts.

Mayor Hunschofsky thanked Mr. Runcie for being here. She stated she has appreciated the partnership the City has had over the years with you and Abby [Freedman]. For those that do not know, the addition at Riverglades was through a developer donation. It was delivered/built a year earlier. Thank you for looking outside the box, and at solutions rather than problems. It has been a great experience working with the school board, the staff and principals. Mr. Bianchi, from Westglades is here today, and one of his students is placed in the top nationally. It is amazing what is happening. To be clear, we are not in the boundary process for next year?

Runcie replied that is correct. Based on all the plans we have today, we are good.

Hunschofsky said we really appreciate everything, and we love it when other cities look to us as an example. Our schools are a source of pride for the City, and I think we can feel very good about our future.

B. Westglades Middle School Girls Soccer Team

Mayor Hunschofsky stated the Westglades Middle School girls' soccer team finished their season undefeated. This year's team consisted of 9 new players, 6 of which were 6th graders.

Their efforts on the field resulted in all wins, but their efforts in practice and their work ethic enabled such a successful season. This is a young group which bodes well for the future.

Their season ended in the second round of the playoffs when they lost narrowly in penalty kicks against Lyons Creek. That ending, however, does not detract from an amazing season for this group of girls committed to working hard.

C. Westglades Girls Cross Country Team

Mayor Hunschofsky stated Broward County added cross country to the middle school athletics this year and approximately 40 middle schools participated at the County championships on October 12th.

The Westglades girls' team placed 2nd overall and the boys' team placed 6th overall.

For the girls' Sabrina Fortney placed 10th out of 169 participants and for the boys' Connor Greep placed 4th out of 199 participants.

Congratulations to all Westglades cross country team members and their coach Sheryl Arriola for an outstanding performance in their first year in County competition.

A. ORDINANCE 2017-14: YEAR-END BUDGET AMENDMENT (2ND READING)

An Ordinance of the City Commission of the City of Parkland, Florida, amending Ordinance No. 2016-18, which ordinance did adopt the budget of the City of Parkland for Fiscal Year 2016/2017, and amending the City Budget thereby adopted to cause and reflect by an increase in the General Fund by \$3,780,000 and in the Capital Projects fund by \$3,000,000; the sources on the increased revenue/resources along with the destination of said expenditure appropriation of funds are as reflected below; providing for severability; providing for an effective date; providing for codification.

City Attorney, Andy Maurodis, read the title for the record. Assistant City Manager Nancy Morando, stated the item reflects the costs incurred as a result of Hurricane Irma debris removal. The removal was extensive, and spanned passed October 1, so costs will be reflected in the next fiscal year budget as well. No comments from the public.
