VI. PUBLIC HEARING

A. NEW BUSINESS

- 1. ORDINANCE AMENDING FUTURE LAND USE MAP** Consideration of an Ordinance of the City Commission of the City of Parkland, Florida amending the Future Land Use Map to change the designation of approximately 26.5 gross acres from Palm Beach County rural residential (RR10) to residential - 3 units per acre (R-3); located along the south side of Loxahatchee Road, east of and adjacent to the L-36 canal; legally described as parcel "A" of Sabra Plat No. 1, according to the plat thereof as recorded in plat book 180, page 87 of the Broward County, Florida public records; providing for an effective date. Case Number: LUPA17-001

Director Michele Mellgren explained to the Board that the applicant did not get the mail notice out. Public Hearing item VI. A.1. is tabled to a date certain of April 12, 2018. Motion passed unanimously (7-0).

- 2. FOUR SEASONS ENTRY, AMENITIES, AND FOUNTAINS** Consideration of a Resolution of the City Commission of the City of Parkland, Florida, amending the Parkland Royale Site Plan, subsequently renamed "Four Seasons" to allow additional lake fountains, a modified fountain structure, new identification signage, and modified clubhouse features; located along the south side of Loxahatchee Road, approximately 5,500 feet west of Nob Hill Road; legally described as Parkland Royale according to the Plat thereof recorded in Plat book 182, Page 60 of the Public Records of Broward County; providing for an effective date. Case Number: SPA18-001

Director Michele Mellgren explained that the Petitioner is requesting minor Site Plan Amendment approval to add lake fountains, modify north buffer, and add entry signage to each of the communities. This is the KHovnanian project, our 55 and over community with 538 dwelling units. Mellgren reminded the Board that they will not see the proposed signs because they are Community Appearance Board, therefore, it will go directly to the City Commission.

Ali Palmer, representing the Applicant, gave a brief PowerPoint presentation. Palmer states that they are adding one lake fountain per lake for a total of 12 fountains. Every lake will have a fountain throughout the entire community. They are also modifying the eastern portion of the north buffer. They are proposing to remove the fountain in the north buffer area and plant a mix of trees, shrubs, and ground cover which will flow into the rest of the buffer.

Board Member Nate Klisberg has personal issues with fountains due to maintenance issues and agrees completely with changing the north buffer to landscaping. Klitsberg inquired if there was any discussion with KHovnanian and the residents about adding the fountains and the financial obligations that follow.

Sharon Cino, representative for KHovnanian, states that this is something we wanted to add and the residents wanted to see. Cino states she will look at the costs related to maintenance. Klitsberg felt this was important when it goes before the City Commission.

Board Member John Willis motioned to approve with staff recommendations. Lynne Fenoglio seconded the motion. Board passed (6-1) with Board Member Klitsberg dissenting.
